# Softera.GPAIS using

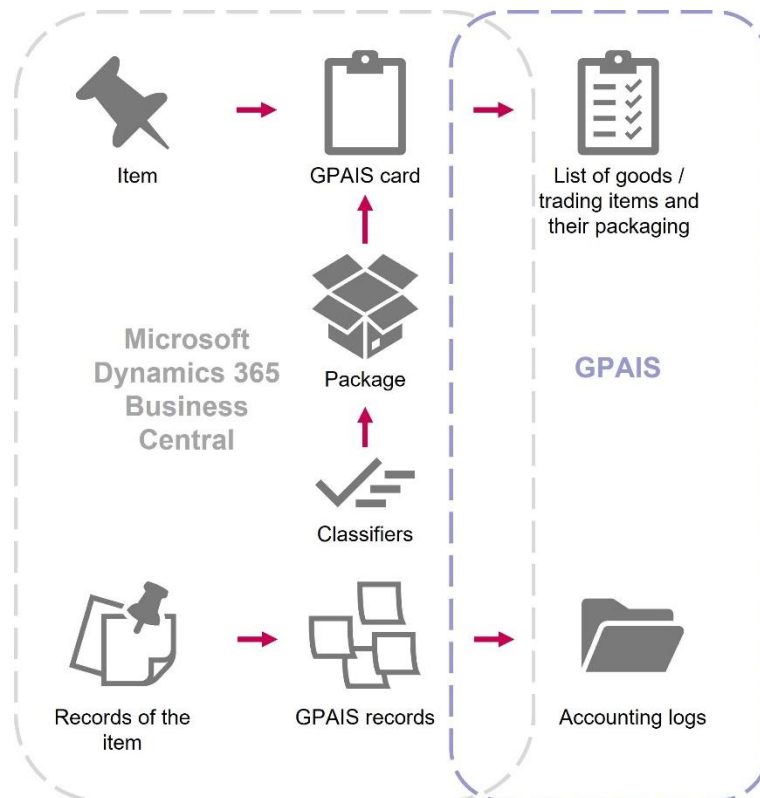
Softera.GPAIS solution is created for producers and importers to account packaging of goods and trading units according to PPWIS (GPAIS from here on out) regulations and automatically provide data from Dynamics 365 Business Central system (BC from here on out) to GPAIS database system (Unified Product, Packaging and Waste Record Keeping Information System).

Softera.GPAIS includes:

- Accounting of packaging of product/sales units
- Accounting of taxable products
- BC integration with GPAIS system, reports, and setup
- The newest classifiers

Benefits:

- Accounting of packages according to GPAIS requirements
- BC integration with GPAIS system
- Retracing and control of accounted data
- Ensures compliance with laws of environmental protection
- Consultations on GPAIS and packaging



# Functionality

## Accounting of packaging of product/sales units

In BC it is possible to describe different types of packaging for one trading unit. Packages are divided into few categories according to which it is possible to identify how particular package is accounted in the company: by writing-off, selling or consumption. All this information is provided in GPAIS card.

- Package is accounted by product/sales units' stock to market. Packaging is calculated according to the assigned weight of sold goods
- Packaging is accounted by periodic write-off (e.g., stretch tape). Used packaging is calculated according to the weight of written-off materials
- Consumed packaging for company's own use (package quantity is calculated according to item entry type)
- Supply of empty packaging to the market. Packaging is calculated according to the amount of transmitted packaging and assigned weight of the packaging

It is possible to create product/sales units by using the tool and card templates. User can create the template, assign required packages and create product/sales units for significant quantity of items using the tool.

## Accounting of taxable products

Taxable products have separate flows which are used to create product/sales units:

- Oil
- Vehicles
- Electronics
- Batteries
- Taxable products

User can create product/sales units using the template or create product/sales units for a significant quantity of items using the tool. Taxable products weight is calculated based on item net weight or could be entered manually.

## Newest classifiers

Functionality goes together with all newest classifiers that are needed for GPAIS and are released together with Softera.GPAIS solution.

- Automated assignment of packaging codes
- Only relevant packages and classifiers are visible to users
- Checking if the packages are assigned correctly

## BC integration with GPAIS, reports and setup

When starting to work with Softera.GPAIS, standard setup and classifiers are uploaded to BC system and user needs to select classifiers and flows which are used in the company.

Accounting of products/sales unit packages is performed in GPAIS product/sales unit journal. Products/sales units and GPAIS entries are exported to GPAIS using web services. Before export to GPAIS user could export to file product/sales unit list or GPAIS entries and to check data. Also, data can be checked by using BC reports:

- GPAIS package by FR0524
- GPAIS package by material
- GPAIS reusable packages
- GPAIS product summary
